All businesses that sell beer and/or wine within Hillsborough town limits are required to obtain a business license. Please ensure you have received your approved license before conducting business within the town's jurisdiction. This policy was levied by the Hillsborough Board of Commissioners in accordance with North Carolina General Statute 105-113.77:

§ 105-113.77. City malt beverage and wine retail licenses.

(a) License and Tax. — Except in cities declining to require a license pursuant to G.S. 105-113.71(c), a person holding any of the following retail ABC permits for an establishment located in a city shall obtain from the city a city license for that activity. The annual tax for each license is as stated.

ABC Permit	Tax for Corresponding License
On-premises malt beverage	\$15
Off-premises malt beverage	\$5
On-premises unfortified wine, on-premises fortified wine, or both	\$15
Off-premises unfortified wine, off-premises fortified wine, or both	\$10

(b) Tax on Additional License. — The tax stated in subsection (a) is the tax for the first license issued to a person. The tax for each additional license of the same type issued to that person for the same year is 110% of the base license tax, that increase to apply progressively for each additional license. (1985, c. 114, s. 1; 2019-6, s. 4.4; 2021-150, s. 4.3.)
